## THE 97 WLAV, THE TICKET, 105-3 HOT FM, THUNDER 107-3 AND THE Q 94-5'S "RISE" CONTEST OFFICIAL RULES

The Station will conduct the **97 WLAV**, **The Ticket**, **105-23 Hot FM**, **Thunder 107-3 and** the **Q 94-5s "Rise"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
